

University Libraries

Stetson University has three separate libraries: one each on the DeLand campus, Gulfport Law campus, and the Tampa Law campus. Each library provides students and faculty with access to electronic and print resources, computers, meeting spaces, and study spaces in a fully networked environment. Access to the duPont-Ball Library's resources is limited to students, faculty, and staff at the DeLand campus. Access to the resources provided by the Dolly & Homer Hand Law Library and the Tampa Law Center Library is limited to faculty, students, and staff at the Gulfport Law and Tampa Law campuses.

duPont-Ball Library

The duPont-Ball Library librarians and staff advance teaching and lifelong learning, collaboration, and innovation while supporting the University's educational mission through its services, information resources, technologies, and facilities.

The library holds more than 217,000 print volumes, 315,000 government documents in all formats, and provides access to approximately 273,000 books and 232,000 journals in electronic format. Over 200 general and specialized databases are provided as well. A strong collection of scores, CDs, and streaming audio and video subscriptions supports the curriculum. Specialized formats, such as compact discs, phonograph records, and musical scores, support the School of Music.

The library has many computer workstations to provide the resources and equipment necessary to do research, evaluate results, and write papers. Students may check out laptops, tablets, digital cameras, and other learning technologies to help them with their work. Librarians provide assistance in person, via email or text, and are available for in-depth research assistance by appointment. Facilities include quiet study areas, collaborative spaces, individual study spaces, group study rooms, and a 24-hour computer lab.

Also housed in the library building is an Innovation Lab where students can experiment with 3D scanning and printing, virtual reality applications, and use a variety of 'MakerSpace' equipment. The Writing Center, located in the northeast corner of the main floor of the library, employs peer tutors to assist students in constructing writing assignments. The Hollis Family Student Success Center (HFSSC) is a dynamic and inclusive learning hub located on the second floor of the duPont-Ball Library. Designed to cater to a diverse range of student needs, the HFSSC boasts dedicated spaces for group study, readily available walk-in services, and a multitude of individual study nooks thoughtfully distributed throughout the space. It is a place where every student can create the ideal conditions for their academic success.

Within the HFSSC are an array of invaluable services offered by the Academic Success department to bolster students' academic journey. Housed in one location are Success Coaching, Subject Area Tutoring, Discovery Advising, General Advising Support, and Accessibility Services. Additionally, the Center is well-equipped with essential supplies, white boards, and numerous compact smart Kapp boards,

ensuring access to technology and materials that support students' academic pursuits.

The HFSSC stands as a vibrant epicenter of holistic and individualized academic support. The dedicated staff in the HFSSC eagerly invites students to schedule one-on-one appointments through SSC for comprehensive student support or to drop by during walk-in hours.

Dolly & Homer Hand Law Library

The Dolly & Homer Hand Law Library works in partnership with the College of Law community to support the curriculum and programs, promote student and faculty scholarship, and provide access to collections, services, and spaces supporting teaching and research. The Law Library also aims at promoting intellectual growth and providing legal information for the Stetson University community, alumni, the judiciary, and members of the bar. The Law Library Archives supports the College of Law by collecting, storing, and organizing a wide variety of historical records, publications, photographs, and artifacts.

The three-story Law Library in Gulfport offers modern and comfortable spaces, and it is a central part of the Stetson community, especially the students' law school experience. The Law Library also houses the Academic Success and Bar Prep Services Department, as well as the Media and IT Departments. The Library is home to 29 study rooms, 135 study carrels, one lounge, one social commons area, four classrooms, and a meditation room.
